The Executive Committee shall be composed of the board chairperson, vice-chairperson, treasurer, and the agency administrator as an ex officio member. The Board Chair shall determine when the Executive Committee is called to meet. The Executive Committee shall make recommendations to the Board, and act in an advisory capacity, but shall not act on behalf of the Board. Purpose: The main purpose of the Executive Committee is to

facilitate decision making between board meetings or in urgent and crisis circumstances. Examples of Executive Committee functions include review of new board policies or changes to existing board policy, personnel matters, and significant financial decisions. The Executive Committee may also serve as a smaller sounding board for the agency administrator before recommendations are brought to the full board. Other Committees: Ad-hoc committees of the Board shall, when specifically charged to do so by the Board, conduct studies, make recommendations to the Board, and act in an advisory capacity, but shall not act on behalf of the Board..
