#### Brief Job Description

CESA 2 seeks a Licensed Professional Counselor or Licensed Clinical Social Worker to provide personal and group counseling services, including AODA groups and substance abuse counseling, to inmates in the Rock County Jail. This is a part-time, limited-term employment position with the person in the position working 15- 20 hours per week or around 52 hours per month.

Duties include:

- Provide counseling treatment services including
  - Alcohol and Drug Addictions Education/Treatment
  - Thinking For A Change (T4C), 25 lessons
  - Community Self-help Education
  - Domestic Violence Counseling
  - Relapse Prevention
  - Behavior Modification Techniques (Included in T4C & AODA)
- Provide individual counseling sessions a minimum of five (5) hours per week
- Provide group counseling a minimum of nine (9) hours per week
- Facilitate the Jail Mental Health Program a minimum of twelve (12) hours per week including mental health assessments, thorough evaluations, crisis intervention, 1:1 supportive contact for inmates housed in E and F Units or in the RECAP Programs of the Rock County Jail
- Keep and maintain records related to RECAP inmate counseling participation and the counseling treatment program content

The ideal candidate will have experience working with individuals from a diverse range of backgrounds, have an ability to build rapport quickly and excellent verbal and written communication skills.

#### Qualifications

Must have or be eligible for Wisconsin licensure through the Department of Safety and Professional Services as either a Professional Counselor or Clinical Social Worker.

#### Education/Experience

Master's degree or higher in counseling or related field. Experience working as a Licensed Professional Counselor or Licensed Clinical Social Worker in a variety of settings preferred.

#### Skills Required

Excellent oral and written communication skills, strong organizational skills, ability to work collaboratively with all staff members, experience in assessing and monitoring client progress, developing and implementing counseling sessions, and experience facilitating group counseling sessions.

#### Compensation and Benefits

CESA 2 is a governmental subdivision and participates in the Wisconsin Retirement System serving 74 school districts in south-central and south-eastern Wisconsin. Benefits for full-time employees include health insurance, dental insurance, life insurance, long term disability insurance and paid sick days.
